Part 1

The president of the CSVEI, Anne Daems, welcomes all participants to the last plenary session of the CSVEI in 2025 and reminds everyone that live translation is provided in French and English as needed, since only one TOD interpreter is available today.

The plenary assembly adopts the agenda.

The **attendance list** is reviewed.

After the **group photo** is taken for publication on the MFSVA social media channels, **Max Hahn, Minister for Family Affairs, Solidarity, Living Together and Reception of Refugees, welcomes the CSVEI members.**

He emphasises that the MFSVA's work on community living relies heavily on the **support of the municipalities**. In this regard, he is pleased that new municipalities will be joining the 48 municipalities that have already signed the *Gemeengepakt* in the coming weeks.

The Minister also highlights the importance of the *Biergerpakt*, which helps promote living together through activities that allow people to better understand the country, its administrative procedures, its institutions, and many other aspects.

He then informs that on November 28, 2025, the **National Action Plan Against Racism (PAN AR)** will be submitted for approval to the Council of Government and, if adopted, will be presented on December 1st to the Commission for Family Affairs, Solidarity, Living Together, Reception of Refugees, Gender Equality and Diversity of the Chamber of Deputies, to the press, and to the monitoring group.

Finally, he recalls that the **National Action Plan for Intercultural Living Together (PAN VEI)**, provided for by the *loi du 23 août 2023 relative au vivre-ensemble interculturel*, is currently being developed.

He thanks all full and substitute members of the CSVEI for their valuable work during 2025 and wishes **good collaboration for 2026**.

C. Margue regrets that training under the REVEIL project is not compulsory for municipal officials.

C. Geier adds that it would be useful to focus more on municipal council members.

C. Jérouvelle explains that resources for the REVEIL project are limited and that it is not possible to offer more training dates at this stage.

A. Daems points out that participants in this training play a multiplier role and that it is already beneficial if a few members of municipal councils who are members of CCVEIs take part.

C. Margue questions the contribution of the 'Ensemble Quartier' project to community life and asks whether interventions only take place when issues are identified in a neighbourhood. C. Czaika explains that the project is not limited to responding to problems. They organise activities throughout the year to strengthen social cohesion and enhance the neighbourhood, such as the *fête des voisins*, neighbourhood festivals and the decoration of the playground of the local school.

Following the presentation, C. Margue asked why there is a collaboration between ASTI and the *Agence du Bénévolat*, but not between CLAE and the *Agence du Bénévolat*. A. Helpiquet (CLAE) explained that the *Agence du Bénévolat* did not wish to take a position on citizen participation, which prevented any collaboration.

In this context, C. Geier emphasised the importance of volunteering and suggested that this topic be explored in greater depth by the CSVEI.
