Part 1

The president of the CSVEI, Anne Daems, welcomes all participants to the first plenary session of the CSVEI in 2026 and reminds everyone that live translation is provided in French and English.

The plenary assembly adopts the agenda.

- **Subject proposal for a conference organised by the CSVEI**

Charles Margue proposes organising a conference on the issue of social cohesion in Luxembourg. He suggests inviting Camille Peugny, author of the essay *Le triomphe des égoïsmes*, to address the issue of social cohesion, which is also a concern in Luxembourg.

- **Presentation and workshops** of projects selected in the 2025 call for projects ‘Promoting cultural diversity and (re)discovering Luxembourg’ by the project leaders, including:

Part 2

- **Follow-up of the BUREX meeting held on February 10, 2026**

At the last meeting, members of BUR.EX were briefed on the ongoing study on extremism.

Members of BUR.EX gave their views on the 2027 budget proposals for the budget line ‘CSVEI operating costs’.

- **CSVEI budget 2027**

The CSVEI has two budget items: one for **expenses related to the attendance fees** (jetons) and another for the **operating costs**. Operating costs cover:

- Interpreters
- Stand costs
- Workshop / small budget for a facilitator
- Training: potential topics include anti-racism, interculturalism and intergenerational issues; two training courses per year will be offered on an ongoing basis

- Legal assistance for drafting opinions
- Follow-up to the study (based on the results and recommendations): development and production of awareness-raising materials
- Conference series: round-table discussions, presentations based on the study's results and recommendations (budget requested for 5 conferences / 15 speakers – Luxembourg and abroad)

Miscellaneous

- Follow-up GT Biergerpakt

Nadine Erpelding reports on the last two meetings of the *Biergerpakt* Working Group.

At the meeting on 9 January, the catalogue and the **user experience** were presented by A. Franziskus and J. Brosius (MFSVA). New activities, company visits and a **buddy programme** enabling participants to bring a guest along to an activity are in the pipeline. A **podcast** to inform German cross-border workers about their rights, opportunities and daily life in Luxembourg was released in January. A version aimed at French-speaking cross-border workers is planned for 2026.

The meeting on 6 February focused on **the Biergerpakt ambassadors** project and how to define their roles. CEFIS has 300 multipliers, and one idea would be to train them as *Biergerpakt* ambassadors. One observation is that the term 'integration' is still often used in discourse instead of 'intercultural living together'. A solution to this problem would be to offer training courses, possibly in collaboration with ASTI, CLAE and the *Agence du bénévolat*. To reach a Luxembourgish audience and long-term residents, there should be more communication in Luxembourgish and more visits organised for this target audience.

Claire Geier adds that it would be better to consider an advisory opinion on the *Biergerpakt* for 2027. She calls on CSVEI members to join the *Biergerpakt* Working Group and notes that they too can act as ambassadors in their local communities.
